

## Privacy Policy for MedicoHealth Token Sale

MEDICOHEALTH AG, a company established under the laws of Swiss Confederation (»Medicohealth«, "we", "us" or "our"), is committed to protecting and respecting your privacy.

This Privacy Policy, together with our **Terms and Conditions for Participating in the Medicohealth Token Sale** available at [www.medicohealth.io](http://www.medicohealth.io) and any other documents incorporated thereto by reference ("**Terms and Conditions**") sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us.

Unless a different use is indicated herein, or required due to the context, the terms used in this Privacy Policy shall have the same meaning as provided for in the Terms.

This Privacy Policy applies to your (»you«, »user« or »customer«) purchase of Medicohealth Tokens during the token sale (as applicable, hereinafter: "**Tokens**"), in accordance with the published Terms, accessible via [wwwmedicohealth.io](http://wwwmedicohealth.io) (the "**Website**"), and issued by Medicohealth (the »**Sale**«), as well as your any other form of participation in the Sale, or interaction or use of the Website.

Please read the following Privacy Policy carefully to understand our views and practices regarding your personal data and how we will treat it. By visiting the Website, participating in the Sale and acquiring any Tokens, you are accepting and consenting to the practices described in this policy.

We reserve the right to amend or modify this Privacy Policy at any time and in response to changes in applicable law or our business practices, or due to technical or any other grounded reasons or issues that might emerge during the Sale.

Any changes we may make to this Privacy Policy in the future will be posted on this page and, when appropriate and necessary, notified to you by e-mail. Please check back frequently to see any updates or changes to this Privacy Policy.

### Information we may collect from you

We may collect and process the following data about you as a Buyer as defined in the Terms:

#### 1. Information you give us

We require users who participate in the Sale and acquire any Tokens during the Sale to give us certain personal identification and contact information. Depending on the scope of whitelisting and compliance with Know-Your-Customer ("**KYC**") and Anti-Money-Laundering ("**AML**") regulations and procedures (as specified in the Terms), you may be asked to provide the following personal identifiable information: your personal name, address of the permanent residence, date of birth, place of birth, citizenship, ID (personal document) number, type of ID, date of issue of the ID, expiration date of the ID, e-mail address,

telephone number, your ERC-20 compliant wallet address from which you will send ETH to Medicohealth Ethereum Wallet and your ERC-20 compliant wallet address to which you wish to receive Medicohealth tokens. You will need to be physically present and identify yourself to us by using your ID. Should you purchase Medicohealth tokens on behalf of a legal entity you represent, you will be required to provide us with the following information: Legal entity's name, registered office, business address, registration number, name of the representative, country of registration, tax ID number, e-mail address, excerpt from the business register which is not more than three months old. The legal entity's representative will need to be physically present and identify himself to us and provide his personal information listed in the previous paragraph.

If you have a reason to believe that someone has provided us with your personal information, or wish to discontinue your participation in the Sale, and you would like to request that your personal information be removed from our database, please contact us at [support@medicohealth.io](mailto:support@medicohealth.io).

Notwithstanding the foregoing, we will hold the above information for as long as is necessary in order to provide you with the service on the Website, deal with any specific issues that you may raise or otherwise as is required by the applicable law (including, but not limited to KYC and AML regulations).

## **2. Information we collect about you**

With regard to each of your visits to the Website and participation in the Sale:

- quantity of purchased Tokens, date and hour of purchase, and identification number (address) of ETH wallet;
- information about your visits, including the full Uniform Resource Locators (URL) clickstream to, through and from the Website (including date and time);
- products you viewed or searched for; page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page; and
- technical information, including the internet protocol (IP) address used to connect your computer to the internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform;
- any other information with regard to the participation in the Sale we might receive from any other sources.

We may receive information about you from publicly available sources. We are also working closely with third parties (including, for example, business partners, sub-contractors in technical, payment and delivery services, advertising networks, analytics providers, search information providers) and may receive information about you from them.

## **Cookies**

The Website uses cookies to distinguish you from other users of the Website. This helps us to provide you with a good experience when you browse the Website and also allows us to improve the Website. For detailed information on the cookies we use and the purposes for which we use them see our Cookie Policy, as outlined below.

## **Uses made of the information**

We use information held about you in the following ways:

- to enable your participation in the Sale;
- to provide you with information about other services that you request or that we offer which are similar to those that you have already purchased/provided or enquired about;
- to notify you about changes to our services;
- to ensure that content from the Website is presented in the most effective manner for you and for your computer;
- to comply with applicable KYC/AML regulations or any other applicable laws;
- to prevent fraud and other prohibited or illegal activities;
- to protect the rights and safety of our affiliated entities and third parties, as well as our own;
- to monitor compliance with our Terms;
- to ensure you receive information relevant to you;
- to administer the Website and for internal operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes;
- to allow you to participate in interactive features of our service, when you choose to do so;
- as part of our efforts to keep the Sale and the Website safe and secure.

## **Disclosure of your information**

We do not distribute or share any customer personal information, except as noted in this Privacy Policy, or as may be required by law and when we believe that disclosure is necessary to protect our rights and/or to comply with a judicial proceeding, court order, or legal process.

We use the information we collect to set up the Sale for individuals and their organizations. We may also use the information to contact customers and prospects to further discuss their interest in the Sale, the other services we provide, ways we can improve our services, and

send information such as announcements of promotions and events regarding MedicoHealth or our partners.

We may also email you a newsletter and/or updates about the Sale, our company or our other services. You can opt out of receiving these communications by following the instructions at the bottom of each such message, or at any time by contacting us at [info@medicohealth.io](mailto:info@medicohealth.io).

We may disclose your personal information to third parties in any of the following events:

- if Medicohealth or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets;
- if we are under a duty to disclose or share your personal data in order to comply with any legal obligation;
- to keep you up-to-date on the latest service announcements, updates, special offers or other information that we think you'd like to hear, either from us, our business partners or third parties.
- in order to enforce or apply our Terms and any other relevant agreements;
- or to protect the rights, property, or safety of **Medicohealth**, our customers, or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction; or
- other events as outlined in this Privacy Policy.

We will not otherwise provide your personal data to a third party without obtaining your prior consent.

### **Correcting, Deleting and Updating Your Information**

Upon request, we will provide you with information about whether we hold or process any of your personal information, whether on behalf of a third party or otherwise. To request this information, please contact us at [support@medicohealth.io](mailto:support@medicohealth.io).

If your personally identifiable information changes, or if you no longer desire to participate in the Sale, you may correct, update, discontinue the participation in the Sale or delete it by making the change on our member information page or by emailing our Support at [support@medicohealth.io](mailto:support@medicohealth.io). We will respond to your request to access within 30 days.

We will retain and use your information as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements.

We use a third party platform host, who hosts the forms on our site, they do not have any access to the personal information that you submit on our website.

## **Where we store your personal data**

The data that we collect will be stored on the cloud with the hosting infrastructure based in the European Economic Area ("EEA").

We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy.

Please note that by visiting and using the Website, participating in the Sale and giving us your personal data, you consent to your personal data being collected, used, processed, disclosed and stored by us, only as described in the Terms and this Privacy Policy.

## **Safeguarding personal data**

The communication internally between our servers (e.g. between application server and database) is handled via secure socket layer ("SSL") to provide AE-256 encryption and all information between our servers and your browser is handled via SSL (up to 256-bit encryption, depending upon your browser), providing an industry-standard level of protection for data in-transit.

You should always make sure that your browser can validate the Website's certificate.

All encrypted data is signed using a message authentication code (MAC) so that the underlying value cannot be modified once encrypted.

We also implement an advanced security method based on dynamic data and encoded session identifications in a secure server environment using preventive, detective and corrective technology and processes to safeguard information from attackers. These safeguards help prevent unauthorized access, maintain data accuracy, and ensure the appropriate use of data.

The security of your personal information is important to us. When you enter sensitive information in our registration or order forms, we encrypt that information using transport layer security (TLS) technology. We also encrypt any information entered within the platform once users log into their accounts. If you have any questions about security on our Website, you can contact us at [support@medicohealth.io](mailto:support@medicohealth.io).

Where we have given you (or where you have chosen) a password which enables you to access certain parts of the Website, you are responsible for keeping this password confidential.

Your passwords are stored on our servers in encrypted form using a one-way hashing algorithm.

Please be reminded that you must protect any passwords or other credentials associated with your account for the participation in the Sale, and take full responsibility for any use of the account under your password. We ask you not to share your password with anyone.

Unfortunately, the transmission of information via the internet is not completely secure and we cannot guarantee the security of your data transmitted to the Website, although we will do our best to protect your personal data. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.

In the case of a personal data breach, we shall without undue delay and, where feasible, not later than 72 hours after having become aware of it, notify the personal data breach to the supervisory authority competent in accordance with [Article 55](#), of the General Data Protection Regulation of the European Union unless the personal data breach is unlikely to result in a risk to the rights and freedoms of natural persons. In such case we will also notify you without undue delay and, where feasible, not later than 72 hours after having become aware of the breach, and suggest any actions to be taken to secure your personal information (change your username and password, etc.).

### **Your rights and access to information**

You may ask us not to process your personal data for a particular purpose, or to access such information, by contacting us at [support@medicohealth](mailto:support@medicohealth). Please note, however, that you shall remain liable for any fees or costs incurred at the time of the withdrawal of your consent to process your personal data. Furthermore, such request may result in you being unable further participate in the Sale.

You may ask us to receive your [personal information](#), which you have provided to us, in a structured, commonly used and machine-readable format and shall have the right to transmit such information to another controller.
